



2008 TIME TRIAL CHALLENGE

at Hudson, WI
Saturday August 30th - 10:00AM

WHERE: Approximately 5 Miles NE of Hudson. Specifically, the start/finish is 2 miles north of County E on County I at the intersection of County I & Valley View Trail.

COURSE: The 18.7 mile Time Trial Course has 885 feet of climbing (47 feet/mile). It is comprised of short rolling hills to start, followed by a flat section with some longer descents and climbs later in the route. ENTRY FEES: Pre-registration postmarked on or before August 16th is \$25.00, thereafter \$30.00. A family rate of 3 or more members available till August 16th at \$20 for first member & \$15 for each additional member. On site registration from 7:00am – 8:30am.

AWARDS: Medals to top three finishers in each male & female Wisport age division and in Open Tandem division. Cash bonuses for overall male & female winners.
